- ... As Chapter members have seen, IFMA has adopted a new logo. Your Chapter will be using this new logo in the near future and we feel that it presents a strong bold image for IFMA.
- ... IFMA '83 will have speakers developing an important theme the problems and solutions to the use and support of electronic equipment in the workplace (and in your department). Seven workshops, in addition to general presentations, will provide small-group solutions sessions. Announcement of 1984 officers, professional day programs, the exhibition, banquet, and opportunities for discussions with colleagues promise that IFMA '83 will be the most important facility management event of the year. Plan to attend and bring your spouse to Denver, Colorado, November 2 4, 1983.
- ... By using IFMA '83's official travel agency, <u>Gelco Services</u>, IFMA members can get a <u>20-25% discount</u> on airfare to IFMA '83 in Denver, November 2-4. Details will be in the conference flyer which IFMA members should be getting in early June.
- ... Alternative methods of processing membership renewals and dues collection are currently being studied by the International office. Until a final decision is reached, the International office will continue to bill members directly for their annual international dues only. Chapters will only bill for local chapter dues. Atlanta Chapter members whose annual membership renewals are due in June will be receiving Chapter dues statements in early June from the Chapter Treasurer, Ms. Christine Williams.
- ... Each Chapter member received with this mailing a copy of the Chapter Membership List dated May 17, 1983. Please check your address, etc. and forward changes or corrections to the Chapter Treasurer, Ms. Christine Williams. IFMA has requested a copy of this list to check the accuracy of their membership files, type of membership, and the date each member was accepted by the Chapter.
- officer positions: president, vice-president, secretary, treasurer. This new procedure is noted in the Spring Facility Management News. Send names of the nominees and their qualifications to Charles Hitch, Manufacturers National Bank, P.O. Box 659, Detroit, Michigan 48231 by June 8. After reviewing the recommended names, the IFMA Nominating Committee will select 1984 nominees and mail ballots to the direct membership in August. The officers will be installed at IFMA '83 in Denver. This is your chance to participate in the growth and development of IFMA.
- ... Your Chapter President is a Director-at-Large on the IFMA Board of Directors and will be attending the IFMA Board Meeting in Chicago on June 17 and 18. The agenda at this meeting will include discussions and possibly a decision regarding IFMA '84 in Atlanta.
