### Charles D. Gandy, FASID

#### Biographical Sketch

Charles D. Gandy, FASID, graduated from Auburn University's School of Architecture with a Bachelor of Interior Design. Prior to forming C. Gandy & Associates in 1979, he held various positions in residential, commercial and hospitality design firms. In addition, he was program director for The American College in Lucerne, Switzerland.

During that tenure, he co-authored CONTEMPORARY CLASSICS: Furniture of the Masters (McGraw Hill Book Company, 1981); winner of the 1984 Joel Polsky Prize for academic contribution to the field of interior design.

Presently working on his second book, Mr. Gandy lectures frequently throughout the country speaking on the contemporary furnishings movements and a variety of other topics.

In October, 1985, C. Gandy & Associates became Gandy/Peace, Inc. Today, Gandy and his partner, William B. Peace, are responsible for nationally award-winning interiors. Their work takes them from coast to coast—San Francisco, California to Naples, Florida and points between.

Mr. Gandy is a former Visiting Adjunct Assistant Professor at Auburn University's School of Architecture. He sits on FIDER's Board of Accreditation (the Foundation for Interior Design Education and Research, which accredits North American schools of interior design). He is an Honorary Member of IDEC (Interior Design Educator's Council) and is the 1988 National President of ASID.
