It has been a year since most of our committee chairmen took their positions (some are serving a second term and some started later, as we felt a need for additional committees). October was the month we felt committee chairs should change, to give new chairmen a start before the officers change in December. This is a good time to look back and see what we have accomplished. Having just completed the formal presentations to National for possible awards, the information is right at our fingertips. We can take great **Pride** in our chapter, for this has been a progressive year.

From an administration standpoint, we have:

- developed a current projected budget, for the first time
- established a set date and time for monthly meetings to encourage regular attendance
- established a regular monthly date and time for executive committee meetings
- increased the number of committees to better distribute workload, and encourage participation
- written specifications for secretarial service and placed them for competitive bids
- developed a philosophy of progression through the offices to allow continuity of programs and provide training in chapter management and structure, possibly leading to advanced leadership
- planned meetings for a year in advance, to allow for better and more varied speakers
- accumulated all available information to compile historical records of the chapter.






Edmond P. Rondeau, AIA, CSI

Since the onset of IFMA Atlanta, international leadership has been developing in the deep South. One of three members to "grow up" in the Atlanta chapter is Ed Rondeau.



Not only a charter member, but one who was instrumental in the formation of the chapter, Ed has continued as a forerunner in leading IFMA to higher standards and growth.

Ed Rondeau is Project Consultant for Contel Material Management Company where he is responsible for strategic planning, the acquisition of real estate and the coordination of design, construction and facility management consulting services for regional warehouse distribution centers being established around the U.S. Prior to this, Ed was the Manager of Corporate Real Estate for Contel Corporation where he was responsible for providing strategic planning, real estate, design, construction and facility management consulting services for property owned and leased by Contel throughout the U.S. He also managed the develop-



ment and implementation of a computerized real estate management system to track Contel's over 4,000 owned and leased properties.

His experience also includes serving as the Vice President of Property Management for the National Bank of Georgia, as the Vice President of Construction and Design for Arby's, Inc., a Construction Manager for the Coca-Cola Company, a Staff Architect for Auburn University, and the Corporate Architect for Ladner & Company, a Developer/Realtor/General Contractor based in Mobile, Alabama.

He is the 1990 Chairman of the International Facility Management Association Foundation, was the 1987/1988 President of the International Facility Management Association (IFMA) and received the 1989 IFMA Distinguished Author Award, the 1988 IFMA Distinguished Member Award and the 1988 IFMA Facility Management Achievement Award. His other professional memberships include the American Institute of Architects (AIA), the American Institute of Corporate Asset Management (AICAM), and the Construction Specifications Institute (CSI).

In addition to addressing professional groups in the U.S. and Canada, he has spoken on real estate and facility management in England, Japan, West Germany, Australia and New Zealand, and has had articles published in the *National Real Estate Investor Magazine*, The Office Magazine, the IFMA Journal, the IFMA News, the Facility Management Journal, and the AFM Newsletter.

His education includes a Bachelor of Architecture from the Georgia Institute of Technology and an M.B.A. in Real Estate from Georgia State University. He is a registered architect in Georgia, holds a Georgia real estate license and is the co-author of the facility management software package known as *FacilityKIT*.

Ed Rondeau continues to demonstrate his commitment to excellence and is respected among his peers for his ongoing contributions to the International Facility Management Association.
