According to IFMA News (November 1992), IFMA signed a letter of understanding with the Institute of Business Designers at IFMA '92 in New Orleans. The agreement, signed by 1991-1992 IFMA President Samuel E. Johnson and IBD President Cheryl Duvall, specifies the organizations' primary common goals.

These common goals include to both associations with support information and education, to further understanding of. facility management by commercial interior designers, to promote the continued development and maintenance of high standards of professional conduct within both professions and to provide dialogue and networking between the two associations.

IFMA and IBD have agreed to keep each other informed regarding their respective activities during the year and to report their accomplishments. In addition, both organizations have agreed to offer each other's members member discounts on national seminars, conferences and publications; the opportunity to submit and/or present papers or seminar topics at conferences and meetings of either organization; and the opportunity to submit to each other papers for possible publication by the other organization.

November Recap

At our November meeting, Mr. Graham Scott, Vice President of Technical Advisory Services and Vice President of Service Management, Inc. for Interface Flooring-Systems, Inc. presented "Factors Affecting Carpet Appearance Retention."

Although performance (wear) and maintainability are important, carpet appearance retention is probably most critical to keeping carpet customers/ end-users satisfied with a product. We want carpets that "resist change, stay new looking and don't show traffic." Years of research and testing have given Mr. Scott some answers as to how to identify construction characteristics of these products. Factors that affect appearance retention include: face weight, pile height, balanced construction, density, spinning system, twist levels, heat setting, fiber modification ratio, pile lay, denier per filament, hand and fiber choice. No wonder we're confused!

It is extremely important to know what you need from a carpet and to deal with a mill that is prepared to show you before the sale what to expect for long term appearance retention based on wear, soiling and maintenance factors. Take the time to get the correct specification and a responsive mill as a partner in your project.
